#### 6. Organizational Changes (Effective from June 28, 2022)

① Establishment of Sustainability Promotion Department

#### (1) Contents

The IINO Environmental Task Force, Business Administration Department and Office Leasing and Operation Department, which have been promoting measures related to safety, environment, and quality within the Group, will be split and integrated into Sustainability Promotion Department.

### (2) Purpose

In our mid-term management plan "Be Unique and Innovative: The Next Stage - Toward 2030" announced on May 15, 2020, we clearly stated our commitment to promoting ESG management, which aims to enhance corporate value while tackling environmental, social, and economic issues head-on. As part of the "Sustainability Initiatives," a priority measure for this purpose, the IINO Environmental Task Force was established in August of the same year to play a central role in environmental preservation, and effective from June 28, 2022, the existing Task Force will be

changed to Sustainability Promotion Department to further strengthen management with an emphasis on sustainability.

## 2 Establishment of Technical Department

#### (1) Contents

The organization of Marine Department will be split into Technical Department as an independent department.

## (2) Purpose

The Marine Department is promoting research and development of new technologies to reduce the environmental impact of ships and technical verification for further expansion of next-generation bunker fueled ships. The organization will be split into Technical Department from Marine Department effective from June 28, 2022, to accelerate efforts related to all Group-controlled vessels, and to achieve the GHG reduction target.
