### (1) Contents

Establish DX Promotion Department as an independent division to further strengthen DX promotion.

### (2) Purpose

In order to play a central role in cross-organizational DX promotion, the IINO DX Taskforce, which was established in August 2020 with members from multiple companies and departments of the Group. The IINO DX Taskforce will be reorganized and a DX Promotion Department with full-time staff members will be established effective from June 28, 2023, as an independent organization with the mission of promoting DX throughout the Group, aiming to realize digital innovation while accelerating DX response.
